After five years of successful recycling, the City of Colchester has decided to rededicate itself to its recycling program and sign on with Jackson Disposal of Seaton, Illinois for its solid waste services which includes curbside pickup of garbage, yard waste and recyclables. The new five year contract will begin July 1, 2003.

The City of Colchester can be proud of its citizens and especially proud of its fourth grade constituents. For two years running, the fourth grade class at Colchester Elementary school has won the Can-Do-Contest - a TCR&WMC event designed to educate children

about recycling and celebrate America Recycles Day.

The combination of community participation and dedicated consistent solid waste education has resulted in a successful five year solid waste management program in Colchester.

The recycling program will continue to use 18 gallon curbside bins. However, the current green bins will be replaced with yellow in the near future.

The TCR&WMC congratulates this community for its efforts.

## Recycling Factoid



According to Recycle America's statistics: if only 250 people (including you of course) each recycled one can a day, we would save the energy equivalent of 1,750-3,500 gallons of gasoline every year. Now try that calculation with 250,000 people; just one can a day could save the energy equivalent of between 1.75 and 3.5 million gallons of gas. And that's only 1% of the U. S. population, with a single can apiece.

## What a Year For a Special Fifth Grade Class!

This has been a really great year for Westmer Elementary School's 5th Grade class taught by Mrs. Waters! Student Erika Brown was one of the top three winners in a statewide poetry contest with classmate Averi Wilson receiving special recognition. The contest was sponsored by the Illinois Environmental Association. The entire class won a \$50 grant from the Mercer County 4-H Federation to purchase tools to use when planting flowers at the New Boston Museum each year. In addition, the class won a \$500 grant from the Illinois Department of Natural Resources to purchase microscopes and make future field trips possible. The class won a \$500

grant from the Aledo Wal-Mart to be used for environmental projects. The students had a display at the store showing some of the great projects they participated in during the school year. And finally, the class won a \$50 certificate from Boney's Farm Store for placing first in the Earth Day Contest sponsored by the Tri-County Resource & Waste Management Council.

The school itself was responsible for keeping a mile of the Mississippi River clean and helping to take care of the communities that they live in. When reflecting on her class and the school, Mrs. Waters said, "We are proud to be part of the Westmer Elementary School and to be able to help out the environment with special awards and grants. # Community

## Making It Easy to Dispose of Difficult Waste

**The McDonough County Board has supported its communities throughout the county in their commitment to clean up**



**How often do you see a random cluster of trash alongside a country road? The McDonough County Board says “Too often,” and supports its communities to rid themselves of trash that has been ditched, literally.**

Bethel, Colchester-Tennessee, Eldorado, Emmet, Industry, Macomb, New Salem, and Scotland townships are having annual cleanups to collect large items and “white goods” (stoves, refrigerators, washers and dryers, etc). The McDonough County Board has supported these efforts of the townships by funding the disposal of these wastes for the last seven years.

Bardolph, Blandinsville, Bushnell, Colchester, Good Hope, Industry, Macomb, Prairie City, and Sciota municipalities are also holding at least one annual cleanup for their residents for the same items. Several municipalities fund these special collections through solid waste contracts for their residents that include this service.

The results are noticeable. Fewer “orphan wastes” are found in road ditches in McDonough County. So far this year, over 150 “white good” units have been hauled into the townships in the Tri-County’s area. The count is still out on municipal efforts.

## Grant Funding Available

The Department of Commerce and Economic Opportunity (DCEO) awards grants to assist local governments, profit and non-profit businesses, and organizations with their recycling efforts. Grants can be used to purchase equipment, and develop and distribute materials designed to promote specific projects. The maximum grants are \$50,000 for collection programs and \$100,000 for primary processing projects. Grant funds are available from the Illinois Solid Waste Management Fund.

## General Assembly Update

In the waning hours of the Illinois General Assembly, both the Solid Waste Fee and the “Subtitle D Management Fund” fees were raised. The bill that was passed was SB 1903. It looks like the increase is \$1.10 per ton at the landfill gates. These fees in the past have been used to support solid waste management programs at the Illinois Environmental Protection Agency (IEPA) and the Department of Commerce and Economic Opportunity (DECO). A portion of the increase will go to the General Fund, but it is unclear at this time how much. The bottom line is there will be an increase in the disposal cost for solid waste for everyone using an Illinois landfill and a possible reduction of solid waste programs offered to the general public.

How much will your garbage disposal cost increase? Based upon the average yearly household volume of two tons, that SHOULD mean an increase of about \$2.20 a year...but, this increase will open the door for all waste haulers to justify raising their rates.
